




#### **Hospital Professional Liability Overview**



#### About the company

Client is a not-for-profit health system comprised of teaching hospitals, psychiatric hospital, community hospitals,



behavioral health care, multi-specialty practices and primary care.

#### **Client need**

WTW was hired to address the complex leave of absence and workers' compensation program and devise a model to enhance processes to impact EBITA and result in annualized cost savings.

#### Solutions

- Leave of Absence performance evaluation review of complex leave processes and operational systems
- Workers' Compensation review prevention and post claim processes for gaps and opportunities
- Vendors assess vendor service deliveries and performance outcomes including computer mediated communication

- Demonstrated strategy to produce nearly \$10 million savings to EBITA over a three-year period on the casualty program.


