Bus and Coach Insurance Facility

Cover	<ul style="list-style-type: none"> Comprehensive/Third Party Fire and Theft/Third Party Only
Limit of Indemnity	<ul style="list-style-type: none"> Legal Liability for accidental death of, or bodily injury to, any person is unlimited and third party property damage is covered up to €30million for private cars and €6.5 million for commercial vehicles, including costs and expenses
Insured Vehicles	<ul style="list-style-type: none"> Bus and Coach (vehicles with 9 seats plus driver requiring a D or D1 Licence). Facility to also include associated small public service vehicles (taxi, hackney, limo)
Use	<ul style="list-style-type: none"> Use as a Public Service Vehicle for the carriage of passengers for hire and reward Non hire and reward e.g. nursing homes/charities, sports clubs
Drivers	<ul style="list-style-type: none"> Bus/Coach/Taxi, Hackney/Limo – any authorised driver with the appropriate unendorsed EU driving licence. All other vehicles – open drive 25 to 70 years with a full unendorsed EU driving licence
Geographical limits	<ul style="list-style-type: none"> Republic of Ireland, Northern Ireland, Great Britain, the Isle of Man and the Channel Islands. See policy document for full wording
Excess	<ul style="list-style-type: none"> Glass Breakage (comprehensive cover only) - €250 excess with a limit of indemnity of €2000 each and every claim €1000 Accidental Fire and Theft excess applies each and every claim



Employers Liability (available for Hire and Reward policies subject to certain acceptance criteria)

Cover	<ul style="list-style-type: none">• Legal liability for bodily injury to employees occurring during the period of insurance arising out of and in the course of their employment
Limit of Indemnity	<ul style="list-style-type: none">• €13,000,000 any one event• Unlimited any one period of insurance
Excess	<ul style="list-style-type: none">• €500 each and every claim

Public Liability (available for Hire and Reward policies subject to certain acceptance criteria)

Cover	<ul style="list-style-type: none">• Legal liability to third parties for bodily injury or loss of or damage to property occurring during the period of insurance and happening in connection with the business at the Insured's premises
Limit of Indemnity	<ul style="list-style-type: none">• €6,500,000 any one event• €6,500,000 unlimited any one period of insurance
Excess	<ul style="list-style-type: none">• €500 each and every claim
