

Air Navigation Service Providers (ANSPs)

As the Air Navigation Service Provider sector accelerates through a digital revolution, providers continue to represent a unique type of risk to aviation liability insurers. Innovations, such as remote towers, offer enhanced safety and operational efficiencies and can complement other smart airport technologies. However, not all service providers are moving at the same pace and operational standards differ considerably worldwide. ANSPs present a catastrophe risk profile and unlike other sectors, insurers do not have frequent low-level claims data to analyse for premium modelling.

The challenge for insurers is to understand individual organisations' level of progress. As your risk adviser we are focused on supporting a more technical understanding to promote and differentiate our clients' business.

Ground handlers and refuellers

In a changing aviation insurance market, ground handlers and refuellers both face differing challenges. Day to day low-level loss activity for ground handlers can be high in a fast-paced operating environment. Insurers are scrutinising this sector more closely given the ever-increasing aircraft repair costs. Conversely, a relatively loss-free refuelling book has also drawn attention, where continued soft market conditions have significantly reduced refuellers' premiums to levels where a relatively small claim would wipe out multiple years' worth of premium income. Insurer appetite for this book has begun to decline.
