- Insurance administration and processing of benefit cases are central tasks

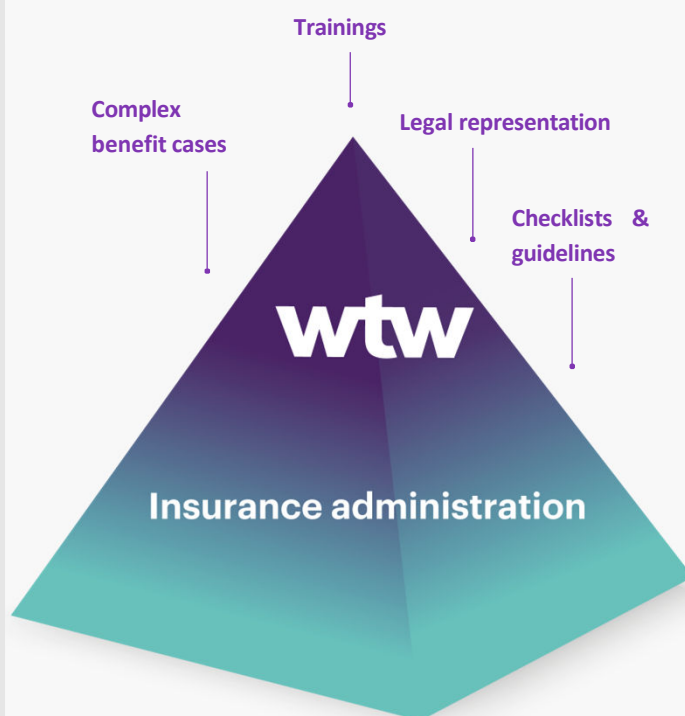
